You are about to purchase a product that is not simple and may be difficult to understand.

What is this product?

Type: This product is an investment fund that can in principle be traded daily and has an unlimited maturity.

Objective: The investment objective is to achieve a return at least equal to the return of the MSCI Europe Index Net EUR, the benchmark. At the same time, the fund employs an investment strategy based on sustainable investment objectives and to realise an ESG score that is as high as possible, taking the risk return profile of the fund into account. The fund also promotes environmental and social characteristics, within the meaning of Article 8 of the SFDR, and aims to contribute to long-term sustainability objectives in the field of the environment and social development and good entrepreneurship.

- The fund invests in equities of listed companies in Member States of the European Union, United Kingdom, Norway and Switzerland that deliver an above-average performance within their corporate sector in the field of sustainability.

- In order to diversify risks, portfolio investments are diversified over countries, industries and companies.

- The fund may also invest in derivatives, exclusively in equity futures and foreign currency forward contracts.

- All companies, governments and institutions in the fund are assessed on their environmental, social and

governance performance (ESG criteria). A negative assessment may lead to the exclusion of companies. In case of doubt, engagement can be initiated to encourage improvement. An ESG score is assigned to all companies in the investment universe. The ESG score of the portfolio is always higher than the ESG score of the benchmark.

- The currency risks arising from the portfolio investments are not hedged into euros.

- The fund pays out a cash dividend at least once a year.

Intended retail investor:

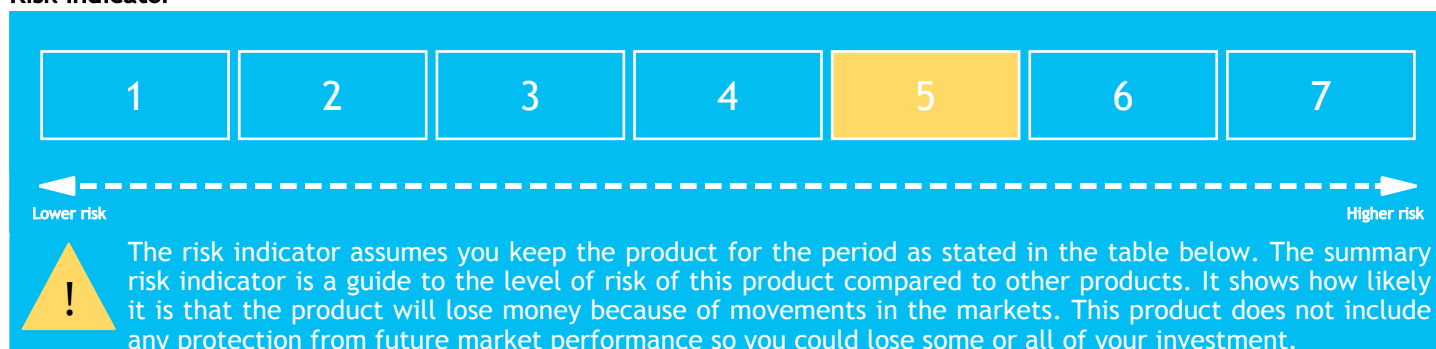
ACTIAM Duurzaam Europees Aandelenfonds is suitable for private and professional investors who invest for the long term. The investor takes into account that he may lose all or part of the investment. Investing in the fund is suitable for both the basic investor with at least some knowledge of the relevant financial markets and products and the advanced investor. The basic investor is in any case able to make an informed investment decision on the basis of the basic information provided to him or by the legally prescribed documentation.

The fund has no end date. Cardano Asset Management N.V. may not unilaterally terminate the fund

What are the risks and what could I get in return?

Risk indicator



We have classified this product as 6 out of 7, which is the second-highest risk class. That means the potential losses on future performance are estimated as high. The product may be exposed to risks such as equity market risk, currency risk and ESG-risk. This product does not include any protection from future market performance so you could lose some or all of your investment.

What happens if Cardano Asset Management N.V. is unable to pay out?

Should Cardano Asset Management N.V. go bankrupt, this will have no direct consequences on the possibility of payment by the fund. If the fund is terminated or liquidated, the assets will be sold and you will receive an appropriate share of the proceeds, but you could lose some or all of your investment. Your loss will not be covered by any investor compensation or guarantee scheme.

What are the costs?

How long should I hold it and can I take money out early?

Recommended holding periode: 5 years

Given the nature of the fund's underlying investments, a minimum holding period of 5 years is recommended. The fund generally invests in risk-bearing assets. Investments in the fund are less suitable for investors with a short-term investment horizon. Exit fees may be charged at the product level.
