Fund Profile

ACTIAM Responsible Index Fund Equity Europe (FBI) passively invests in shares of listed European companies through physical replication. The objective is to match the return of the index, the MSCI Europe Index Net EUR. Investments are made exclusively in shares that meet the ESG criteria, as formulated by ACTIAM. This results in a deviation (tracking error) with respect to the index. The funds that become available due to the exclusion of companies are invested such that the tracking error is minimised. Securities lending is not permitted and currency risk will not be hedged.

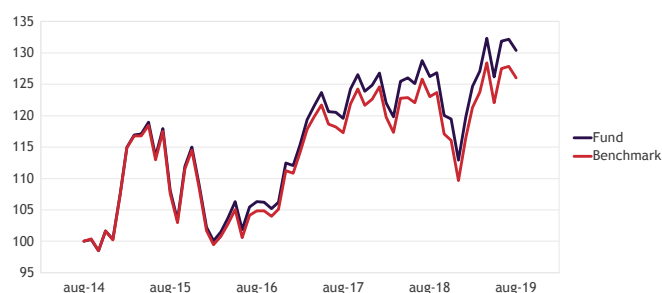

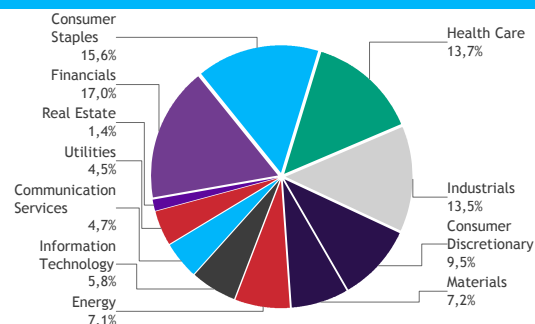
