ACTIAM Verantwoord Index Aandelenfonds Noord-Amerika passively invests in shares of listed North American companies by physically replicating the MSCI North America Index Net EUR. The objective is to match the return of the index. The fund exclusively invests in shares that meet the ESG criteria, as formulated by ACTIAM. This results in a deviation (tracking error) with respect to the index. The cash that becomes available due to the exclusion of companies is invested such that the tracking error is minimised. Securities lending is not permitted and currency risk will not be hedged.

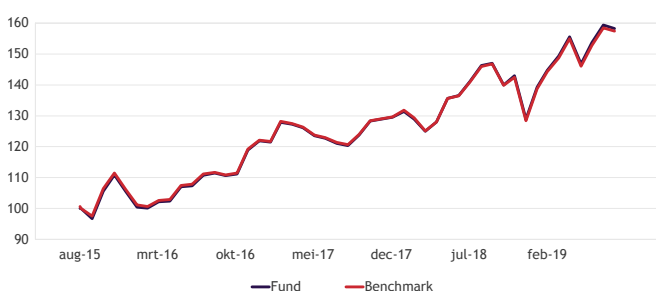

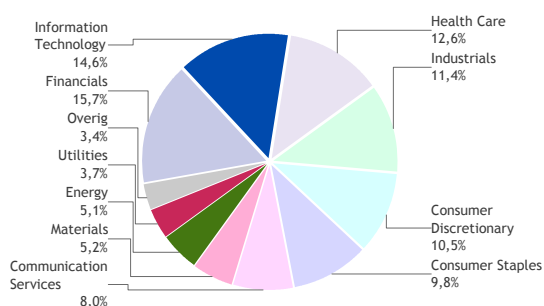
