



Fund Profile

ACTIAM Duurzaam Mixfonds Defensief primarily invests in sustainable corporate bonds denominated in euro, as well as in listed global equities. In addition, the fund may invest to a limited extent in shares of listed European real estate companies and other investment categories, including "high yield" bonds and "emerging market debt". The fund's objective is to achieve a return at least equal to that of the composite benchmark. The investment policy responds to market developments and economic outlook. Depending on this, an allocation across the investment categories is chosen. The fund also promotes environmental and social characteristics, within the meaning of Article 8 of the SFDR, and aims to contribute to long-term sustainability objectives in the field of the environment and social development and good entrepreneurship.

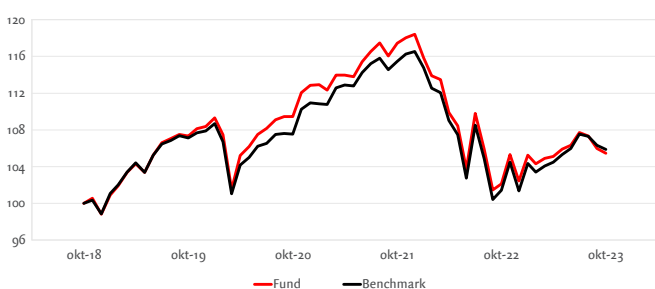

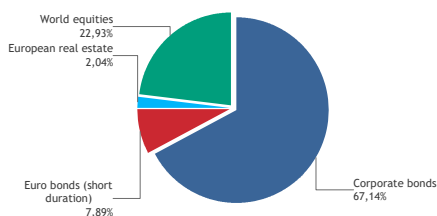
