You are about to purchase a product that is not simple and may be difficult to understand.

## What is this product?

**Type:** This product is an investment fund that can in principle be traded daily and has an unlimited maturity.

**Objective:** The investment objective is to achieve a return at least equal to the composite benchmark. The benchmark consists of: 65% iBoxx EUR Green, Social & Sustainability Bonds Corporates, 25% MSCI All Country World Index Net EUR, en 10% iBoxx € Overall AAA 1-3 (TR). The fund also promotes environmental and social characteristics, within the meaning of Article 8 of the SFDR, and aims to contribute to long-term sustainability objectives in the field of the environment and social development and good entrepreneurship.

- The fund invests on the basis of a sustainable investment policy and mainly in euro-denominated sustainable corporate bonds of predominantly investment grade quality and in listed global equities. In addition, the fund can, for a limited part, invest in listed European real estate companies and in other investment categories.

- Within the equities investment category investments are in principle made for 50% in the regional ACTIAM Duurzaam Index Aandelenfonds funds and 50% in ACTIAM Impact Wereld Aandelenfonds. The latter fund, in addition to the pursuing a financial return target, expressly intends to also achieve non-financial value, by among others investing in companies that actively

contribute to the realization of the Sustainable Development Goals ("SDGs").

- Companies, governments and institutions in the fund are assessed on their environmental, social and governance performance (ESG criteria). A negative assessment may lead to the exclusion of companies or debtors. In case of doubt, engagement can be initiated to encourage improvement. The investment policy makes use of ESG scores, whereby an ESG score is assigned for all investments of the Fund.

- The currency risks arising from the portfolio investments are not hedged into euros.

### Intended retail investor:

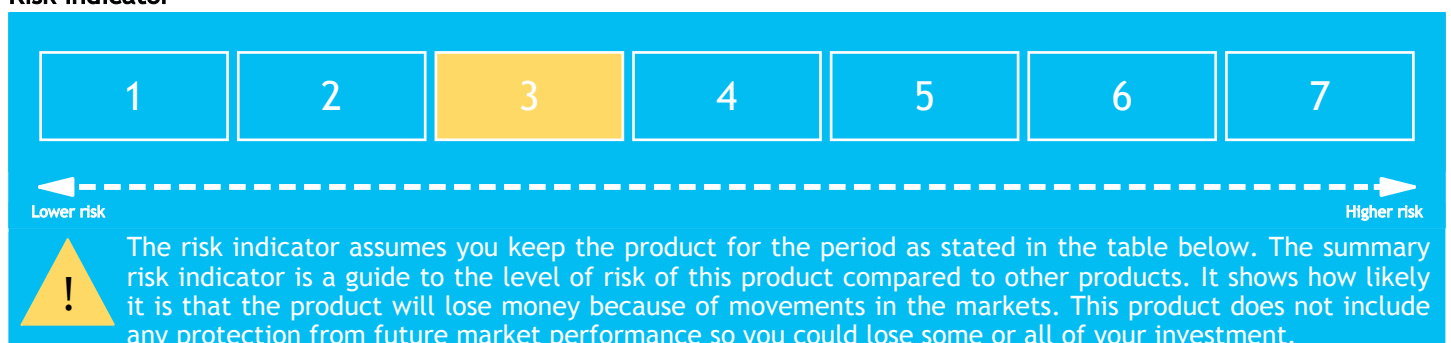
ACTIAM Duurzaam Mixfonds Defensief is suitable for private and professional investors who invest for the long term. The investor takes into account that he may lose all or part of the investment. Investing in the fund is suitable for both the basic investor with at least some knowledge of the relevant financial markets and products and the advanced investor. The basic investor is in any case able to make an informed investment decision on the basis of the basic information provided to him or by the legally prescribed documentation.

## What are the risks and what could I get in return?

### Risk indicator

## What happens if ACTIAM N.V. is unable to pay out?

If the fund is terminated or liquidated, the assets will be sold and you will receive an appropriate share of the proceeds, but you could lose some or all of your investment. Your loss will not be covered by any investor compensation or guarantee scheme.

## How long should I hold it and can I take money out early?

Recommended holding periode: 3 years

Given the nature of the fund's underlying investments, a minimum holding period of 3 years is recommended. The fund generally invests in risk-bearing assets. Investments in the fund are less suitable for investors with a short-term investment horizon. Exit fees may be charged at the product level.
